Within the administration of judicial oversight, the principle of legal certainty principle is increasingly used as a measure of lawfulness of legal acts. At the same time as court practice shows vagueness and obscurity of legal norms does not neces-sarily constitute the breach of such principle. The Russian Federation Constitutional Court and the European Court of Human Rights have held that not all vague laws shall be disqualified as a result.
