Problems of developing anti-corruption legislation to counter corruption committed by persons occupying state positions

The paper examines the draft of the Federal Law 'On introduction of changes into individual legislative acts of the Russian Federation', prepared within the framework of anti-corruption legislation development. The draft of law specifies a list of property and details of expenditures covered for the purchase of such property to be submitted by a person holding one of the positions as indicated in Art.2 of the Federal Law 'On the Control of Conformity of Expenses of Persons Occupying State Positions and Other Persons to Their Income' if the total amount of the transaction exceeds the declared income of the person, their spouse, and underage children.
