#### 'Contract', 'obligation', 'performance': what can be 'repudiated' or 'unilaterally modified'?

Keywords: Obligation: contract; repudiation; unilateral modification of obligations The author considers the issues of unilateral repudiation. What does a debtor repudiate? Do they repudiate a contract, a stipulated obligation or the performance of obligation? Drawing on the applicable norms of the Russian Federation Civil Code, the interpretation of such norms and analysis of their development, the author concludes there exist three types of premises for repudiation: 1) repudiation leading to the abrogation of the contract and all obligations respectively 2) repudiation of contract with no discharge of obligations until they are performed 3) repudiation of obligation without contract termination. The exercise of the right to repudiation in each of the three cases should proceed from clear understanding of what element of the contract will be affected. The author (for the first time in the academic community) brings together and systematizes the norms of the Russian Federation Civil Code which tackle other subjects of repudiation.
